The Title III program is contracted through the Pennyrile Area Development District with funding from the Older American's Act. PACS serves over 6,000 unduplicated clients through the Title III services that include all of the above listed categories. All services are at no charge to individuals 60 years and older. Donations are encouraged and these donations are budgeted back into the county the donation was received. Donations are very important as they are used to expand services in that county.

Home Care is state funded through the Department of Aging and Independent Living and the Pennyrile Area Development District. This program provides in-home services to seniors who have functional impairments that may prevent them from completing the activities or instrumental activities of daily living. Home Care clients must be assessed by a case manager to be declared eligible for this program. There is no charge for these programs, but donations are encouraged to help expand services.



Community Services Block Grant (CSBG)


Pennyrile Allied Community Services, Inc. (PACS) administers the Community Services Block Grant Programs (CSBG) through a contract with the Cabinet for Health and Family Services, Department for Community Based Services. CSBG is designed to address the needs of the low-income residents and to assist them with working towards becoming self-reliant.

The Community Service Coordinators housed in each of the nine counties provide emergency assistance through CSBG funding. PACS Coordinators also provide case management to individuals and referrals to community partners to assist clients with employment, financial management, education concerns, cooking/shopping on a budget and maintaining a home. The focus of CSBG is to provide services as part of case management, which in turn leads to self-reliance.

Through CSBG, various non-federal funding, case management, home visits, telephone calls, referrals and community involvement PACS Community Services has assisted over 690 households with over \$189,900 in one of the following areas of need: Employment, Education, Housing, Income and Asset Building, Health and Civic Engagement.

Low-Income Home Energy Assistance Program (LIHEAP)

The Low-Income Home Energy Assistance Program (LIHEAP) helps keep families safe and healthy through initiatives that assist families with energy costs. Over 12,400 households in the Pennyrile area received \$2,955,088 in home energy assistance benefits.

- LIHEAP Summer Subsidy component operated from July 25, 2022 to September 30, 2022 with 1,571 Households receiving \$537,100 in energy assistance benefits.
- LIHEAP Summer Crisis component operated from July 25, 2022 to September 30, 2022 with 831 Households receiving \$200,769 in energy assistance benefits.
- LIHEAP Subsidy component operated from October 17, 2022 to December 19, 2022 with 3,576 Households receiving \$472,278 in energy assistance benefits.
- LIHEAP Crisis component started January 9, 2023 and ended March 31, 2023 with 4,084 households receiving \$1,393,107 in energy assistance benefits.
- LIHEAP Spring Subsidy component started on April 17, 2023 and ended on June 2, 2023 with 2,350 households receiving \$351,833.
- The Low-Income Home Energy Assistance Program (LIHEAP) helps keep families safe and healthy through initiatives that assist families with energy costs. Over 12,400 households in the Pennyrile area received \$2,955,088 in home energy assistance benefits.

Low-Income Home Water Assistance Program (LIHWAP)

The Low-Income Home Water Assistance Program (LIHWAP) assisted families with water and wastewater cost. 877 households in the Pennyrile area received \$266,330 in water and wastewater assistance benefits.

CDBG-CV

PACS CSBG offices completed CDBG-CV applications for individuals impacted by COVID-19. CDBG-CV funds assisted households with electric, natural, gas, water and wastewater cost. Applications were completed in the following communities: Central City, Christian County, Crittenden County, Drakesboro, Hopkins County, Madisonville, and Todd County.

FAMILY FIRST PRESERVATION PROGRAMS

Amelia Morris, *Director*

These in home services are designed to prevent the removal of children from their families. FFP serves all 17 counties in Western KY. Services are provided through a variety of evidence-based practices and include but not limited to parenting skills, assisting with the reunification of families, advocacy, and community resources.

Community Collaboration for Children

CCC provides preventative services and does not need a referral source. This program is open to all families without DCBS involvement.

Motivational Interviewing

MI is a method of counseling used to promote behavior change by encouraging clients to consider their personal goals and what they are doing to work towards those goals.

·Length of Time: 3 hours a week for 13 weeks ·Maximum Caseload: 6 ·Age: 0-18

Family Functional Therapy

FFT is a short term prevention program for at risk youth with behavioral or emotional problems. It focuses on developing a positive relationship between family members.

•Length of Time: 1.5 hours a week for 12-15 weeks •Maximum caseload: 6 • Age: 11-18-year-old

Homebuilders

Provides intensive in-home counseling and support services for families who have children at imminent risk of removal or reunification.

·Length of Time: 10 hours a week for 4 weeks ·Maximum Caseload: 2 ·Age: 0-18 years old

Trauma-Focused Cognitive Behavioral Therapy

TF-CBT is an evidence-based intervention for children and adults who have symptoms associated with trauma exposure.

*Lenth of Time: 1-1.5 hours per week for 8-25 weeks *Maximum Caseload: 6 *Age 5-17

Parent-Child Interaction Therapy

PCIT is an evidence-based intervention in which parents are coached by a trained therapist in behavior management and relationship skills.

*Lenth of Time: I hours per week for 12-20 weeks *Maximum Caseload: 6 *Age 2-7

RETIRED AND SENIOR VOLUNTEER PROGRAM (RSVP)

Retired and Senior Volunteer Program (RSVP) recruits and places volunteers that are fifty-five years of age and older in public agencies, secular or faith-based private/public non-profit organizations, or proprietary heath care organizations. RSVP offers flexibility and choice as it matches the personal interest and skills of older Americans with the community

needs throughout Caldwell, Christian, Hopkins, Lyon, Muhlenberg, Todd, and Trigg Counties.

RSVP is federally funded by AmeriCorps Seniors formally known as The Corporation for National and Community Services (CNCS) and matched with local money from Fiscal Courts in Christian County, Hopkins County, Muhlenberg County, Trigg County, United Way of the Pennyrile, and Fundraising.

RSVP's fiscal program year runs April through March. RSVP had a total of 320 volunteers who donated 45,463 service hours at 55 stations doing 72 different jobs throughout our seven counties. The Independent Sector estimated the value of a volunteer's time in Kentucky at \$24.83 per hour. Multiplying that number by the number of hours served was a savings of over \$1,128,846.29 to the non-profit, government agencies, and proprietary health care organizations helped by RSVP Volunteers for 2022-2023.

Tax Counseling for the Elderly (TCE)



The mission of the TCE preparation program is to assist elderly and low-income taxpayers in satisfying their tax responsibilities by providing free tax return preparation. To establish the greatest degree

of public trust the IRS- certified volunteers are required to maintain the highest standards of ethical conduct and provide quality service. PACS along with the RSVP program facilitates to ensure TCE operates efficiently each tax season. PACS had 22 TCE Volunteers that dedicated an amazing 2,921 service hours completing 2,781 Federal and State tax returns with over \$1.4 million in Federal dollars refunded to 1,365 elderly taxpayers. This tax season we were able to structure three temporary sites in Caldwell, Livingston, and Todd Counties.

The Transportation Program's primary purpose is to provide safe, reliable, and affordable transportation to the Pennyrile area. PACS serves Christian, Caldwell, Crittenden, Hopkins, Livingston, Lyon, Muhlenberg, Todd, & Trigg counties in the Pennyrile area. We at PACS Transportation are proud to be providing the residents of the Pennyrile Area with a service to meet their transit needs.

We are still operating with the same vehicles that we have had because we have not been able to purchase any new vehicles for the past 2 years. The funds continue to build in hopes of purchasing new vehicles sometime within the next year. As of right now if we could, we would try to purchase at least 30 replacement vehicles to our aging fleet.

We are still working towards building a new transportation building in Hopkinsville to replace the old transportation annex building. It seems to be getting closer to reality as we are currently receiving bids to have the old building demolished, making way for a new construction site. Future plans on that building include a maintenance facility to be able to do maintenance on our own vehicles making it more cost efficient and provide better maintained vehicles. In FY21 PACS was awarded 5311 CARES Capital for 1.5 million to renovate the Transportation building on 1200 S. Clay St. We have also been granted \$500,000. Additional funds through the 5339b grant to help cover the increasing costs that have risen over the past few years due to the pandemic.

PACS ended the city transit routes in Madisonville (GoMad) because of the low ridership. The contract was not renewed by the city for FY24. We continue to operate City Transit Systems-PACS bus routes for the City of Hopkinsville (3routes). They provide different routes to different areas of these counties to assist with transit needs and give people the independence to go when they want without having to rely on someone else to take them. Ridership is still really low compared to pre-covid.

PACS had grant funds for onboard camera systems awarded in FY22 and was trying to wait for new vehicles before we started the process, but it doesn't appear any new vehicles for transit agencies will be available anytime soon over the next few years. PACS began the process of installing on-board camera systems on their vehicles. The first installment of 50 on-board cameras was completed in April. The second installment of 15 vehicles was completed in June. PACS has a total of 65 vehicles that have camera systems on them with all cutaway buses having them. This will make our vehicles safer because people will less likely do things they shouldn't. This is also looked at very highly by our insurance because it will give us documentation on any-thing that is questioned on our vehicles. It is our plan going forward to have camera systems on all vehicles.

WEATHERIZATION

The scope of the Weatherization program continues to be one of assisting in the achievement of a more helpful dwelling environment and maximum energy conservation for low-income clients.

The priority measure PACS performs on a house or mobile home is checking the energy systems of the dwelling. This includes furnaces, space heaters, fireplaces, water heater jackets, duct wraps and duct repairs if needed, flue repairs, safety materials and safety repairs. A National Energy Audit is performed on each house and a Manufactured Energy Audit is performed on each mobile home PACS selves. These audits show the areas the Weatherization program should address while performing Weatherization Services.

As the second priority, the major infiltration work is completed. This includes repairing and/ or replacing missing doors, panels, panes; missing windows and/or windowpanes; repairs to supply and return ducts; and major envelope holes. The general heat waste priority is then repaired, blocking is installed, attic bypasses are addressed and sealed, roof repair, which is very limited by regulations, is completed. If necessary, the walls of the dwelling are then repaired and insulated. Floors are repaired, ground cover is installed underneath the structure, pipe wrap, and insulation is completed. With LIHEAP funds combined with DOE, the Weatherization program has completed 15 homes.

ATMOS (C.A.R.E.S.)


The Demand Side Management (DSM) partnership program with Atmos Gas Company is intended to provide current low-income Atmos Gas residential consumers assistance and advice concerning energy efficient improvements specific to their homes.

The program is offered at no cost to the participant. This program acts as a "piggyback" program in conjunction with PACS Weatherization program to ensure the most energy saving measures are completed to conserve the greatest amount of energy. Caldwell, Christian, Crittenden, Hopkins, Livingston, Lyon, Muhlenberg, Todd, and Trigg counties are served by CARES.


The goal of this program is to reduce the energy usage of Atmos Gas residential customers.

In order for one to receive the CARES benefits, one must be eligible for PACS Weatherization program.

The program guidelines are based on the 200% OMB Poverty Guideline. These guidelines are based on number of people in household and allowable yearly income.
